

FAIHP 2020 Photo Contest Rules

FAIHP is excited to see all the wonderful photos from our community. However, to ensure that this contest is as inclusive and fair as possible, we do have a few guidelines:

1. To be eligible, submit your photo to the contest between Tuesday, January 21, 2020 and Thursday, February 13, 2020 at 5:00 p.m. PT.
2. Contest is eligible to all community members.
3. Your photo must be appropriate for all audiences. Please refrain from submitting photos that depict violent or otherwise inappropriate imagery.
4. Photos that are blatantly promotional and depict a brand or products of commercial value will be disqualified. Adding logos or text to images or combining images is not allowed.
5. Please note that by law, we are required to have a photo release for any photo that includes an individual or individuals who are in a private place or where there is a reasonable right to privacy. Photographs of any persons under the age of 18 or others on private property or in a setting with the reasonable expectation of privacy must be accompanied with a photo release form turned in with your photo(s). If you do not have your own form, you may download one at www.faihp.org/photocontest. Each entry will be evaluated to ensure it represents our values and has appropriate release forms signed (if applicable).
6. **Selected photos will be announced on February 25, 2020 at the Community Potluck.**

FAIHP retains ownership and all other rights to future use of the photographs they enter. In addition, entry to the contest constitutes your agreement to all your entered photographs to be used for promotion by FAIHP for their purposes, including, but not limited to, production of brochures, promotion of future contests, public relations, advertising, education, books, place in facility and other media, without compensation.

WHAT TO ENTER

Images will be selected on originality, cultural relevance, technical excellence, composition, overall impact and artistic merit.

To ensure functionality on our submission platform, please submit files no larger than 5400 x 4032 pixels and no smaller than 4 MB at the time of entry. High resolution-original files will be requested should an entry make it into the final round of editing to be considered for use.

All photographs should accurately reflect the subject matter and the scene as it appeared. Photos that have been digitally altered beyond standard optimization (cropping, spotting for dust, reasonable adjustments to exposure, color and contrast, etc.) will be disqualified.

Entries may originate in any format—including but not limited to digital files, digital prints, color transparencies, color prints, or black and white prints—so long as they are submitted electronically in a .JPEG .jpg, or.png format. HDR images are acceptable. Work can be turned in on USB drives or SD cards or uploaded to our website.

Please include images that have a cultural significance to you.
